

**CITY OF ENGLEWOOD**

**BOARD OF HEALTH REGULAR MEETING**

**May 11, 2016**

1. The regular meeting of the Board of Health, City of Englewood, Bergen County, was called to order at 8:04 p.m. by Dr. Ketsia Sadler, President, Board of Health.

**MEMBERS PRESENT:**

Dr. Ketsia Sadler, President; Stephanie Davis, Vice President (arrived 8:15 p.m.); Bertha-Nora Acosta; JoEllen Bostick; Daniel Daniel; and Dr. Aliza Solomon.

**ALSO PRESENT:**

James Fedorko, Director, Health Services/Health Officer/Secretary to the Board; William C. Soukas, Esq., Board of Health Attorney; and Janet Hart, Confidential Executive Secretary.

**ABSENT/with apology:**

Dr. Lisa Wisotsky

Mr. Fedorko read the Open Public Meetings Statement. All stood to recite the Pledge of Allegiance.

2. A. Items for Approval

Motion to approve 2. A. i. (Minutes of April 13, 2016 Meeting-Open/Closed); 2. A. ii. (Receipts-\$41,600.00-April, 2016-); 2. A. iii. (Bills-\$2,073.50-April, 2016-); and 2. A. iv. (Employee Reports-April, 2016).

Motion to approve Items 2. A. i.-iv. was made by Ms. Bostick, and seconded by Ms. Acosta. Motion was approved 5-0.

2. B. Motion to approve retail licenses, April, 2016, and corrected retail licenses, March 1 – April 8, 2016

Mr. Fedorko explained that the error in the list of retail licenses for March 1 – April 8, 2016 had been corrected and that the license approvals would be attached to the minutes as "Schedule A," with the Board's approval. He said that there had not been any written or verbal objection to the approval of these licenses.

Motion to approve retail licenses for April, 2016, and corrected retail licenses for March 1 – April 8, 2016, was made by Dr. Solomon, and seconded by Ms. Bostick. Motion was approved 5-0.

There were no Board Reports for the month of April, 2016.

### **RESOLUTIONS**

3. R16-04 Resolution to Reaffirm Bylaws

Mr. Soukas read Resolution R16-04, reaffirming the Board's Bylaws, in its entirety. Motion to approve Resolution R16-04 was made by Mr. Daniel, and seconded by Ms. Bostick. Motion was approved 5-0.

### **OLD BUSINESS**

4. NJ Well Program

Mr. Fedorko reported that 61 people attended the NJ Wellness Program, which was well received. There were only two locations hosting this event in Northern New Jersey, Englewood and Mahwah. He believes that when word gets around about how easy it was to participate and receive a gift card that attendance at the next NJ Wellness event will increase. One drawback was that it was held on the second floor of the Recreation Center, which was a problem for some people.

5. Englewood Moves

Mr. Fedorko announced that the Englewood Moves Wellness Program would be ending on May 19, 2016. He said a bicycle and helmet would be given away on Tuesday, May 17<sup>th</sup>, which was partially donated by Strictly Bicycles in Fort Lee. At the grand finale on Thursday, May 19<sup>th</sup>, gift cards will be raffled. An after-action review will be done after the final event.

### **NEW BUSINESS**

6. Annual Report on the State of the Englewood Community's Health

Mr. Fedorko reviewed the leading causes of death and morbidity of Englewood residents in 2015, the relationship between morbidity and mortality, and the goals of the Englewood Health Department. He said the causes of death of Englewood residents are similar to the causes of death in New Jersey and in the country. An association between diabetes and cancer was discussed. Mr. Fedorko said a primary goal of the Englewood Health Department should be to decrease the diabetes rate, improve efforts to reduce the obesity rate, improve educational

outreach with cancer, improve the flu and pneumovax vaccination programs, and sustain efforts to limit food borne illnesses.

7. Other Business

Ms. Bostick inquired if the Department had been able to offer the Diabetes Program in Spanish. Mr. Fedorko replied that the class in Spanish had not yet been offered by Healthcare Quality Strategies, Inc., but as soon as it is offered, the Department's Senior Registered Environmental Health Specialist and Health Educator will enroll in it. If the Department is awarded a grant from Aetna, a certified Diabetes Health Educator will be hired for this. Mr. Fedorko stated that the Department also applied for a grant, along with Fairleigh Dickinson University, for a Population Health Nursing program, in which nurses would go out into the community to share information.

**PUBLIC COMMENT**

Motion to open the time for public comment was made by Ms. Davis, and seconded by Ms. Acosta. Motion was approved 6-0.

Nellie Bobe, 376 Orchard Street

Ms. Bobe stated that it had been reported to her that the dryers in the Hudson Avenue laundromat are moldy, and asked if the Health Department could check on that. She requested a copy of the Board of Health Bylaws. She preferred the Walk with a Leader program at Winton White Stadium held last year to this year's Wellness Program at Mackay Park. She requested that she be put on the mailing list to receive the Department newsletter via email. She suggested the Department set up a table at the City's Memorial Day Parade to hand out informational pamphlets in Spanish.

Motion to close the time for public comment was made by Dr. Solomon, and seconded by Ms. Acosta. Motion was approved 6-0.

Mr. Soukas then read the Closed Session Resolution, as follows:

WHEREAS, the Open Public Meetings Act of the State of New Jersey permits the public to be excluded from certain matters to be discussed by the Board; and

WHEREAS, the Board of Health of the City of Englewood desires to discuss the Sofia litigation and the evaluation and contract of the Health Officer; and

WHEREAS, these matters are ones which permit the exclusion of the public from such discussions; and

WHEREAS, minutes will be taken during the closed session, and a summary of the minutes will be made available to the public by the next public meeting, and once the need for confidentiality no longer exists the minutes will be made available to the public,

NOW, THEREFORE, BE IT RESOLVED, by the Board of Health of the City of Englewood that the public be excluded since these matters, as set forth above, are ones which permit the exclusion of the public from such discussion: pending or anticipated litigation or contract negotiation/attorney client privilege, and employment matters relating to any specific prospective or current employee unless the individual requests in writing that the matter be discussed in public.

Motion to begin the closed session was made by Ms. Davis, and seconded by Ms. Acosta. Motion was approved 6-0.

**(Closed Session)**

Mr. Soukas updated the Board on the case of Smoke, Inc./Sofia Restaurant pending in Superior Court.

The Board discussed the evaluation and contract renewal of the Health Officer.

Motion to adjourn was made by Mr. Daniel, and seconded by Dr. Solomon. Motion was approved 6-0.

The meeting ended at 9:25 p.m.
