**AUTHORIZATION TO PREPARE AND ISSUE 2013 ESTIMATED TAX BILLS**

**WHEREAS**, the City of Englewood cannot have its overall tax rate certified until after the adoption of both the State of New Jersey fiscal budget and County of Bergen budget; and

**WHEREAS**, it may be necessary to issue 2013 third quarter estimated tax bills prior to the tax rate certification in order to collect tax levy receipts in a timely manner to ensure the City of Englewood can meet its financial obligations; and

**WHEREAS**, the City of Englewood Tax Collector and Chief Financial Officer have computed an estimated tax levy in accordance with N.J.S.A. 54:4-66.3, and they have signed a certification showing the tax levies for the previous year, the tax rates and the range of permitted estimated tax levies; and

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Englewood, Bergen County, New Jersey as follows:

1. The City of Englewood Tax Collector is hereby authorized and directed to prepare and issue estimated tax bills for the City for the third installment of 2013 taxes. The Tax Collector shall proceed upon approval from the Director of the Division of Local Government Services to take such actions as permitted and required by PL., 1993.c.72 (N.J.S.A. 4:4-66.2 and 54:4-66.3),
2. The entire estimated levy for 2013 is hereby set at \$103,469,480.12 and the estimated tax rate set at \$2.381,
3. In accordance with the law the third installment of 2013 taxes shall not be subject to interest until the later of August 10 or the twenty-fifth calendar day after the date the estimated tax bills are mailed. The estimated tax bills shall contain a notice specifying the date on which interest may begin to accrue.

**A RESOLUTION SUPPORTING PSE&G's ENERGY STRONG PROGRAM**

**WHEREAS**, the State of New Jersey has experienced a series of extreme weather events over the last two years, including but not limited to: Hurricane Irene, the October 2011 snowstorm, Super storm Sandy and an accompanying Nor'easter; and

**WHEREAS**, the City of Englewood was impacted by said extreme weather events, including but not limited to power outages, downed trees, blown transformers and substations, etc; and

**WHEREAS**, Public Service Electric and Gas Company ("PSE&G") provides [municipality] electric and/or gas service; and

**WHEREAS**, said extreme weather events severely damaged PSE&G infrastructure, including but not limited to: flooded electrical substations due to storm surges, downed power lines and poles due to high winds and fallen trees, and the destruction of gas meters due to contact with water; and

**WHEREAS**, said damages to PSE&G infrastructure contributed to [municipality's] said impacts; and

**WHEREAS**, the New Jersey Board of Public Utilities ("BPU") issued an order on January 23, 2013 directing the State's electric and gas utilities, including PSE&G, to implement certain recommendations in the areas of: "Preparedness efforts", "Communications", "Restoration and response", "Post event", and "Underlying infrastructure issues"; and

**WHEREAS**, PSE&G submitted an infrastructure filing on February 20, 2013 entitled "Energy Strong"; and

**WHEREAS**, "Energy Strong" proposes an investment of \$3.9B worth of infrastructure projects over a 10-year period to enhance PSE&G's electrical and gas system, including but not limited to: fortifying electrical stations, replacing and modernizing cast iron gas mains, deploying smart grid technologies, improving pole distribution systems, creating more redundancies, undergrounding of electricity lines, and protecting gas metering stations; and

**WHEREAS**, the City of Englewood would benefit from the proposed investments in the "Energy Strong" filing.

**NOW THEREFORE BE IT RESOLVED**, that the Mayor and City Council of the City of Englewood, County of Bergen, State of New Jersey formally declares its support for PSE&G's "Energy Strong" program.

**WHEREAS**, the City of Englewood has the need for professional Grant Research and Writing Services for City of Englewood Departments, the Library and the Englewood Volunteer Ambulance Corp (EVAC). The scope of work will include:

- Research, preparation and submission of grants and funding procurement including all appropriate follow up.
- Representation with appropriate legislative and governmental officials and their offices pertaining to grant and funding procurement services.
- Provide and coordinate the necessary communication with all stakeholders and interested parties to achieve the maximum results for specified goals.
- Attendance at designated meetings, as requested, with 48 hour notice.

**WHEREAS**, on the recommendation of the City Manager, the City Council has determined, based on professional experience, expertise and reputation, to award a contract for such services to Millennium Strategies, 60 Roseland Avenue, Caldwell, New Jersey 07006 pursuant to N.J.S.A. 19:44A-20.5 as other than a "Fair and Open" contract as defined therein; and

**WHEREAS**, the Local Public Contracts Law (N.J.S.A. 40A: 1 1-1 et. seq.) authorizes the award of such professional services contracts without competitive bidding; and

**WHEREAS**, the City Manager has determined the value of this contract for the scope of services as stated above and in the attached proposal, is not to exceed \$36,000 for a one-year contract;

**ORDINANCE #13-XX**

**AN ORDINANCE OF THE CITY OF ENGLEWOOD, STATE OF NEW JERSEY RELATING TO GENERATORS; AMENDING CHAPTER 250, ARTICLE XI, DISTRICT REGULATIONS, SECTION 250-59 "ONE FAMILY RESIDENCE DISTRICTS" ADDING SUBSECTION 8 (a-c) TO SECTION J OF THE CITY CODE OF THE CITY OF ENGLEWOOD**

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ENGLEWOOD, IN THE COUNTY OF BERGEN, NEW JERSEY AS FOLLOWS:

Section 1. The City Code of the City of Englewood is hereby amended to include in Section 250-59, Section J, and adding subsection 8(a-c) to read as follows:

J. Regulations concerning yards, planting area, fences, etc.

(8) Emergency generators may be placed in the side yard setback, but outside of the required planting strip provided that:

(a) the generator is no larger than 50kw; and

(b) the generator is no closer to the adjoining residential building than to the residential building on the generator site; and

(c) there shall be vegetative screening that is at least 1 ft. higher than the height of the generator (screening for the adjoining property) and capable of growing at least 3 ft. higher than the generator. Plant materials must be at least 5 ft. from the generator.

Section 2. If any sentence, section, clause, or other portion of this ordinance, or the application thereof to any person or circumstance, shall for any reason be adjudged by a court of competent jurisdiction to be invalid, such judgment shall not affect, impair, or repeal the remainder of this ordinance.

Section 3. All ordinances or parts thereof inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 4. This ordinance shall take effect immediately upon passage and publication as required by law.
