RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF ENGLEWOOD ON THE DEDICATION AND ADOPTION OF THE SEPTEMBER 11TH MEMORIAL

WHEREAS, on September 11, 2001 the United States was the victim of a sudden, unprovoked, terrorist attack on its homeland that resulted in the destruction of the World Trade Center's iconic Twin Towers, severe damage to the Pentagon in Arlington, Virginia and the crash of United Flight 93 in Shanksville, Pennsylvania; and

WHEREAS, the City of Englewood, along with the County of Bergen, the State of New Jersey and the entire United States has suffered greatly from the losses of the terrorist attacks of September 11, 2001; and

WHEREAS, eight victims of the tragic events of that fateful day were from the City of Englewood, Michael S. Baksh, Alejandro Castaño, Frank Joseph Doyle, Uhuru G. Houston, Howard L. Kane, Michael Matthew Miller, Frank Bennett Reisman, Alva Cynthia Jeffries Sanchez; and

WHEREAS, the City of Englewood had been resolute in its commitment to insure that the Englewood victims were memorialized in a way that would honor their memory and also make known the City's desire to future generations to communicate the importance of never forgetting the events of that day; and

WHEREAS, on September 11, 2013 the City of Englewood unveiled its September 11th Memorial located in Veteran's Park on the 12th anniversary of the terrorist attacks that occurred on September 11, 2001 which forever changed our Community and our Country; and
