This letter is to provide you with written notification that the City of Englewood will hold a Public Hearing to obtain comments regarding its Application to the NJDEP Green Acres Program for the proposed minor diversion and disposal of parkland owned by the City of Englewood. This application is subject to NJDEP Commissioner and State House Commission approval and is available for review via the City of Englewood website at www.cityofenglewood.org and at the NJDEP Green Acres Program Offices at the below address. **The virtual Public Hearing will be held on March 23, 2021 starting at 7:00 PM via the City of Englewood's virtual Zoom platform.**

The proposal to divert/dispose of 0.485 acres of parkland (Block 3402, Lot 1 and Block 3404, Lot 3 on the City of Englewood tax maps) is to enable the replacement of the Jones Road over Route 4 Bridge. In accordance with N.J.A.C. 7:36-26.5 (c), the City of Englewood will deed restrict approximately 4.6 acres of Block 3706, Lot 4 on the City of Englewood tax maps as Green Acres encumbered replacement parkland. In addition to oral comments that can be presented during the Public Hearing, written comments may also be submitted to the to the City of Englewood with copy to the NJDEP Green Acres Program, at the addresses listed below. All written comments must be received within two weeks following the virtual Public Hearing or no later than April 6, 2021.
