

**BOARD OF HEALTH

AN ORDINANCE REVISING CHAPTER 6 OF THE HEALTH CODE OF THE CITY OF ENGLEWOOD, IN THE COUNTY OF BERGEN, NEW JERSEY, "FEES AND FEE SCHEDULE".

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF HEALTH OF THE CITY OF ENGLEWOOD, THAT CHAPTER 6 OF THE HEALTH CODE BE REVISED AS FOLLOWS;

Chapter 6. Fees and Fee Schedule

SECTION 6.2 FEES FIXED

The licensing year fee for the several licenses or permits referred to in this Code are hereby fixed as follows:

(f) Retail Food Service Establishments:

(4) Mobile food vendor	
(a) Motorized	\$150.00
(b) Non-motorized	\$ 75.00
(6) Temporary Food License	
(a) Up to 3 days	\$ 75.00 (includes 1 inspection)
(b) Up to 10 days	\$125.00 (includes 1 inspection)
(c) Set-up Deposit	\$ 60.00 (for all licenses)
refundable within 48 hrs. after end of event upon inspector's verification of on-time set-up	
(7) Seasonal events	\$ 50.00
(Farmer's Market, Sports concessions, etc.)	

(h) Toilets, portable

(1) Single-day events	No fee
(2) First installation	\$ 15.00
(3) Each additional installation	\$ 5.00

(i) Foodservice Workers Certification Courses

(2) Food Handlers	\$ 25.00
-------------------	----------

All other portions of Chapter 6, "Fees and Fee Schedule" shall remain unchanged.

This Ordinance shall take effect upon final passage and publication as required by law.
