AN ORDINANCE AMENDING ORDINANCE 06-01,
“ESTABLISHING A FEE FOR VITAL STATISTICS RECORDS
KEPT BY THE REGISTRAR OF VITAL STATISTICS”
AS REQUIRED BY THE OFFICE OF VITAL STATISTICS AND REGISTRY
OF THE STATE OF NEW JERSEY AND N.J.S.A. 26:8-25.

AMENDING OR ESTABLISHING MISCELLANEOUS FEES OF
THE DEPARTMENT OF HEALTH FOR GOODS/SERVICES

BE IT ORDAINED by the Board of Health of the City of Englewood in the County of Bergen as follows:

THAT the fee for a certification (information only copy) of a vital statistics record, also known by the Department of Health of the City of Englewood as a genealogical record, kept by the Registrar of Vital Statistics, as required by the Office of Vital Statistics and Registry of the State of New Jersey and N.J.S.A. 26: 8-25, shall be fifteen dollars (\$15.00) for the first document issued by the Registrar of Vital Statistics and two dollars (\$2.00) for each additional document of the same record issued by the Registrar of Vital Statistics.

AND THAT the Miscellaneous Fee for Vaccinations, provided to the Department of Health by the State of New Jersey under the Vaccines for Children Program or the Vaccines for Adults Program, shall be set at the Administrative Fee allowed by the State of New Jersey for said vaccinations. The Miscellaneous Fee for Vaccinations purchased independently by the Department of Health from an approved vaccine provider shall be at the Department's cost.

This Ordinance shall take effect upon final passage and thirty (30) days after the date of first publication in accordance with law, which shall be on May 30, 2014.
