ORDINANCE 14-03**

An Ordinance to Amend Chapter 4, Article 9, of the Health Code entitled
“Keeping of Bees Prohibited”.

BE IT ORDAINED by the Board of Health of the City of Englewood as follows:

Article 4-9, “Keeping of bees prohibited”, be, and is hereby, repealed in its entirety.

BE IT FURTHER ORDAINED that,

Article 4-9 is hereby replaced with the following: “Bee keeping. The keeping of bees in the City of Englewood is permitted and shall be regulated according to the Best Management Practices of the New Jersey Department of Agriculture, which shall be a part of this Ordinance, attached as Schedule A.”
