AN ORDINANCE AMENDING ORDINANCE 06-01, "ESTABLISHING A FEE FOR VITAL STATISTICS RECORDS KEPT BY THE REGISTRAR OF VITAL STATISTICS" AS REQUIRED BY THE BUREAU OF VITAL STATISTICS OF THE STATE OF NEW JERSEY AND N.J.S.A. 26:8-25.

AND

AMENDING OR ESTABLISHING MISCELLANEOUS FEES OF THE DEPARTMENT OF HEALTH FOR GOODS/SERVICES

BE IT ORDAINED by the Board of Health of the City of Englewood in the County of Bergen and State of New Jersey as follows:

A. Establishing a Fee for Vital Statistics Records

1. The fee for a certified copy of a vital statistics record kept by the Registrar of Vital Statistics, as required by the Bureau of Vital Statistics of the State of New Jersey and N.J.S.A. 26: 8-25, shall be twenty-five dollars (\$25.00) for the first document certified by the Registrar of Vital Statistics and two dollars (\$2.00) for each additional document of the same record certified by the Registrar of Vital Statistics.

2. If Corrections/Amendments are requested for a vital statistics record kept by the Registrar of Vital Statistics, as required by the Bureau of Vital Statistics of the State of New Jersey and N.J.S.A. 26:8-25, and the correction/amendment is due to an error in fact by the family informant, there shall be a charge of twenty dollars (\$20.00) payable at the time the request for the corrected document is made.

B. Amending or Establishing Miscellaneous Fees of the Department of Health

Miscellaneous fees to be paid, for goods and/or services provided by the Department of Health, shall be as follows:

1. Animal Trap Deposit\$40.00
(refundable upon return of trap in good condition)
2. Immunization Record (Duplicate – advance payment required)\$5.00
3. Exigent Circumstances Call-in of Registrar, Deputy or Alternate\$100.00
(non-emergency service during non-business hours,
i.e. issue of marriage license, certified vital record, etc.)
4. Fax Service
 Within New Jersey, 1st page\$1.00
 Outside New Jersey, 1st page\$2.00
 Each additional page\$1.00
5. Notarization (per document)\$2.00
6. Photocopy (per page)\$0.50
7. Vaccines/Screening
 Influenza vaccine\$20.00

Mantoux test	\$30.00
Pneumonia vaccine	\$40.00

This Ordinance shall take effect upon final passage and thirty (30) days after the date of first publication in accordance with law, which shall be on November 1, 2011.
