MESSAGE FROM THE BOARD PRESIDENT

The Englewood Health Department continues to identify and address the health needs of our community. Focusing on education and illness prevention, it provides needed services to all Englewood residents. In late August 2024, Dr. Shatrughan Bastola retired as Director of Health Services/Health Officer. James Fedorko currently serves as interim Health Officer, while Deborah Baldwin serves as interim Director. Both bring experience and knowledge to the roles.

We are proud to note that The New Jersey Health Care Quality Institute has awarded Englewood its 2024 Mayors Wellness Campaign “Healthy Town” award for promoting health and wellness through community-based programs. As one of only 31 municipalities in the State receiving this honor, our city has been recognized as one that addresses the physical and mental health needs of its residents, as well as any public health challenges that may arise.

During the year, the dedicated and skilled Health Department staff managed matters related to communicable diseases, adult and child health, vital statistics, and environmental health and food safety, while maintaining compliance with regulatory requirements. The Health Department has been a strong and visible presence within the city. In partnership with Englewood Health, church and community leaders, and other community organizations, a number of health fairs, wellness events and initiatives were conducted at various locations. These well-received activities provided not only education but testing and evaluation, provision of vaccines, and distribution of information regarding additional resources when needed. Our partnership with the Municipal Alliance continues as we strive to maintain a Stigma-Free environment, supporting those living with mental health and addiction challenges. Volunteers provided additional support to the Department.

We thank the Mayor, City Council and City Manager for their ongoing support of the Health Department and its endeavors. Their support for our annual budget enables the Department to continue its work and remain prepared for future health needs. As well, two grants complement our mission.

I am grateful for the opportunity to serve as President, and along with the entire Board, look forward to the year ahead.

MESSAGE FROM THE DIRECTOR

First, many thanks to our Board of Health members who serve on a volunteer basis. The Board meets once a month, except in August, and provides guidance throughout the year. They ensure that the department provides a competent workforce and creates/enforces policy to protect the health of residents.

As you may be aware, the Director of Health Services/Health Officer retired at the end of August 2024. You may not know that licensed Health Officers are scarce, making recruitment difficult. In the meantime, I have been covering the administrative functions of the department as Acting Director. A former Health Officer for Englewood, James Fedorko, has been the interim Health Officer.

With financial assistance from several grants, we were able to purchase some updated equipment and software for the office. In addition, staff have developed new programs for our residents and purchased a wide selection of items to give away at public events. It is our hope that these programs will continue after the grants are concluded.

A capital request enabled us to complete renovations in the nursing and health education section of the department. Also included was the kitchen/meeting room. This past year, new furniture was purchased for each of these areas.

Our Health Educator, Julie Green, received honorable mention (1st runner-up) in the Mayor's Wellness Challenge "Champion of Health" award. A number of the new programs offered were initiated by Ms. Green. She has improved community health by introducing inclusive, socially engaging programs and expanding community wellness programs for residents.

The staff continue to deliver existing programs. These include, but are not limited to, TASE/VASE (Tobacco/Vape Age of Sale Enforcement), rabies vaccination clinic, child and adult vaccinations, chronic disease management, wellness challenges, substance use prevention, and mental health education.

Finally, my thanks to the staff who strive to achieve the Department's goals and continue to address the needs of the community.

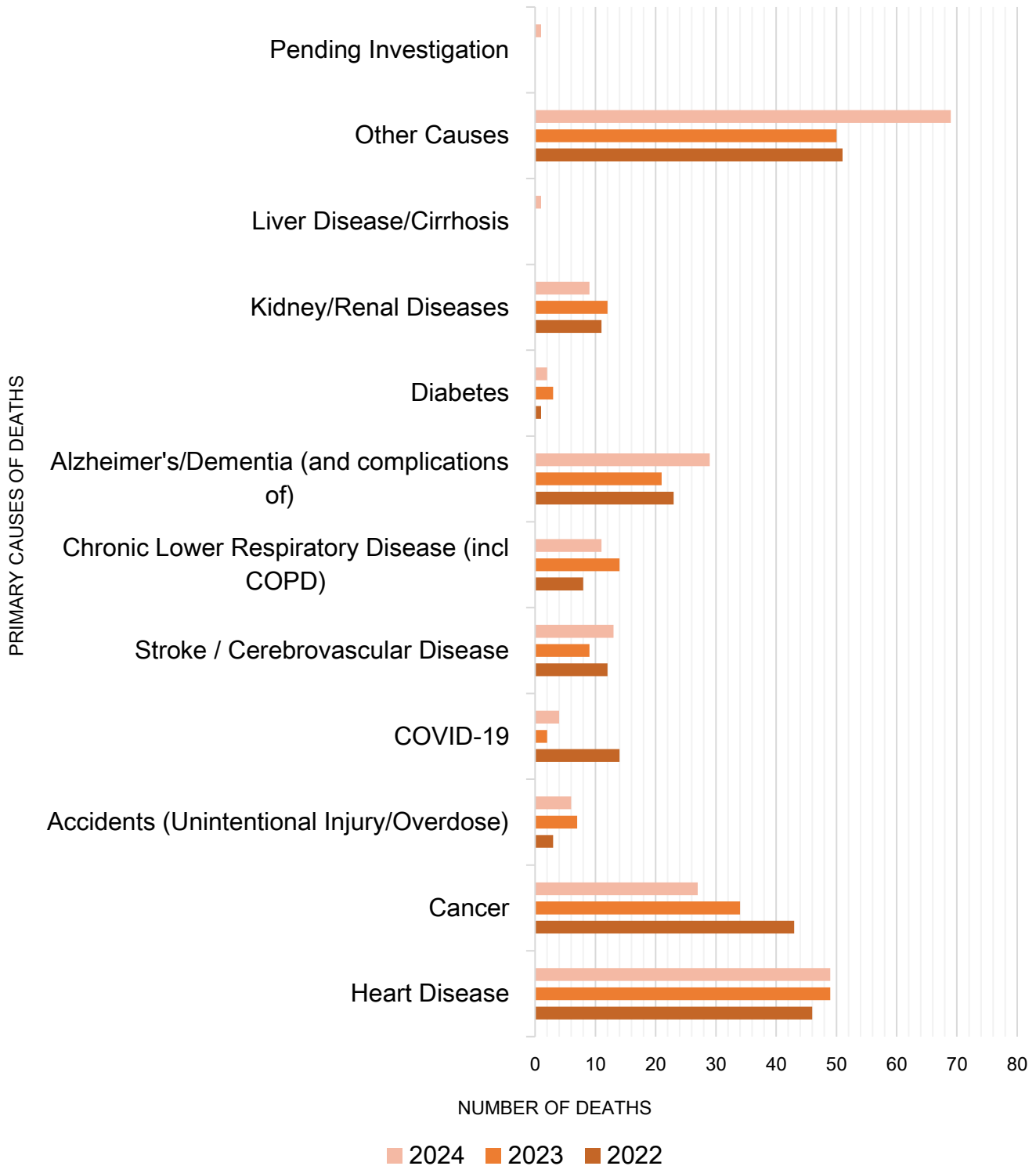
Cancers included 6 cases each of breast and lung cancer; fewer than 5 cases each of liver, brain, colorectal, pancreatic, bladder, endometrial, gastrointestinal, leukemia, mesothelioma, prostate, and unspecified metastatic cancers. Accidental deaths include fewer than 5 cases of substance overdose.

* Indicates counts less than 5.

Statistics show Englewood has had a consistent decrease in the birth rate from 2022 to 2024. The birth rate decreased by just over 1% in 2024 compared to 2023. However, births decreased by -8.41 % in 2024 compared to 2022. Despite the fact the rate of birth decreased the number of resident births showed very little change. Resident births between 2022 and 2024 dipped by -1.7%. Resident births between 2023 and 2024 dropped by less than 1%.

Death certificates, on the other hand, showed more consistency in the number of deaths over the three-year period between 2022, 2023 and, 2024. There is less than -2.5 difference between deaths filed between 2022 and 2024. There were 527 deaths filed in 2022, 516 deaths filed for 2023 and 514 in 2024. Although deaths filed decreased between 2022 and 2024 residency deaths show a mild fluctuation between of decrease from 2022 and 2023 with a slight increase in 2024. Resident deaths in 2024 increased by 9.45% over 2023 and by 3.77% over 2022.

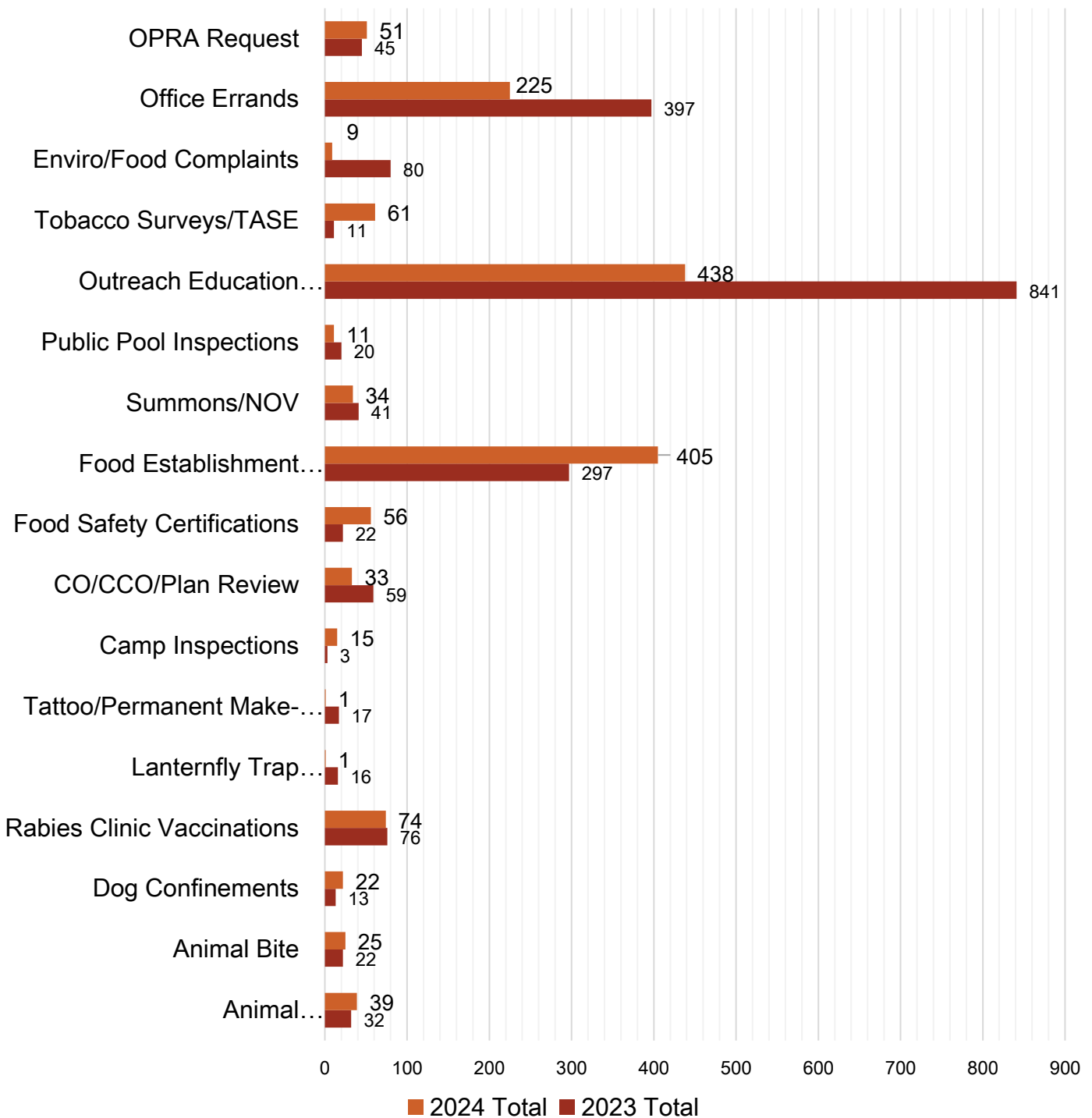

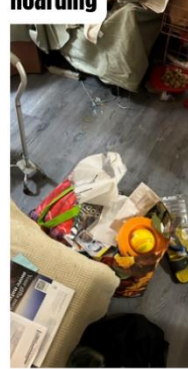

PUBLIC HEALTH NURSING

The Public Health Nursing unit plays a crucial role in promoting and protecting community health by delivering healthcare services aimed at vulnerable and underserved populations. Before the onset of the COVID-19 pandemic, the Department had established a strong reputation for its proactive initiatives and effective health programs, which contributed to improved health outcomes in the community. The challenges presented by the pandemic prompted the Nursing unit to adapt quickly to excel in its mission. In response to the emergence of new diseases, the Nursing unit has significantly expanded its outreach in the area of epidemiology and service offerings to ensure the public's well-being.

Adult Vaccine-Preventable Disease

The Health Department offers a vital program known as the Adult Vaccine Preventable Disease Program (317 Vaccine Program). This initiative provides affordable vaccines to uninsured adults, helping to prevent the spread of infectious diseases. The vaccines available through this program include those for COVID-19, Hepatitis A and B, Human Papilloma Virus (HPV), Measles, Mumps, and Rubella (MMR), Meningococcal disease, Pneumococcal disease, Tetanus, diphtheria, and pertussis (Tdap), Varicella (chickenpox), and Shingles.

This program is particularly beneficial for uninsured adults who require vaccinations for various reasons, such as changes in their residential status, employment requirements, academic policies related to school attendance, or overall well-being. By improving access to these essential vaccines, the Adult Vaccine Preventable Disease Program plays a vital role in promoting public health and preventing the spread of infectious diseases within the community. Vaccines can be received either by scheduling an appointment or by walking in.



Child Health Clinic – VFC Program

Another vital program offered is the Child Health Clinic which provides essential services to uninsured children and those enrolled in the State Health Insurance Plan A. This clinic focuses on preventive healthcare and offers services such as physical exams, immunizations, health screenings, Mantoux skin testing, and sports physical exams. The clinics are offered twice a month – every second and fourth Tuesday.

These services are available to both Englewood residents and non-residents, ensuring that children aged 0-18 in surrounding areas receive the healthcare they need.

Additionally, the vaccines are provided at no cost to participants. However, there is an administrative fee for the services provided.

Community Outreach

The Englewood Health Department successfully administered flu and COVID-19 vaccines to the community, reaching employees, Englewood residents, and those from surrounding areas. It also partnered with Buckley's Drug Store for vaccination clinics. These events were strategically held at accessible locations, including the Englewood Health Department, the Englewood Public Library, restaurants, and popular community events such as health fairs.

The initiative was designed to provide vaccinations and enhance health awareness throughout the community. During flu season, the department aimed to ensure that as many residents as possible received their flu shots and COVID-19 vaccines. Events featured trained health professionals who were available to address any questions or concerns and educate participants about the importance of the vaccines.



Communicable Disease Reporting

The Public Health Nurse will conduct surveillance for communicable diseases as needed, ensuring timely identification and reporting of potential outbreaks. In addition to this critical role, the Nurse has continued to provide valuable support to the Infectious Disease Preparedness Generalist within the department, collaborating on community education initiatives, vaccination programs, and response strategies to enhance public health awareness and safety.

Education and Training

To stay updated on procedures and changes in the public health environment, the Public Health Nurse attended various trainings, seminars, and webinars. These sessions covered the Vaccines for Children program, vaccine-preventable diseases, the New Jersey Immunization Information System documentation, and the New Jersey Inventory Management Order and Distribution System for vaccines. Topics also included communicable disease monitoring and reporting and immunization audits.

In addition to enhancing her knowledge, the Public Health Nurse provides annual training for staff involved in departmental clinic functions. This training includes instruction on the New Jersey Immunization Information System for vaccine entry and documentation, immunization school audits, and the department's daily operations.

School Immunization Audits

The mandate for school vaccinations, established by the New Jersey Department of Health, is enforced through audits conducted by the department. All students are required to be immunized according to the recommended vaccination schedule. School district personnel, such as nurses and administrators, are notified in advance of when these audits will occur. The Public Health Nurse sent a message indicating that the schools' immunization audit would begin in early January. Following this communication, the Public Health Nurse contacted all school representatives throughout January to schedule appointments for these audits, providing specific dates and times for each session.

The audit includes all students, regardless of whether they are enrolled in public or private educational institutions. This encompasses daycare centers, nursery schools, preschools, kindergartens, elementary schools, and high schools.

Both medical and religious exemptions from this mandate are allowed. A religious exemption must be based on documented religious beliefs and include specific language referencing "Religious" in the statement. It is a written statement from the child's parent or guardian which must be dated and signed. In contrast, a medical exemption can only be issued by a physician licensed to practice medicine or osteopathic medicine and certified nurse practitioners. It is important to note that a medical exemption must specify a defined period during which the child is unable to receive certain vaccinations for medical reasons.

Summary

The Public Health Nursing unit plays a vital role in enhancing community health through a wide range of services and programs. It provides immunizations, monitors communicable diseases, engages in community outreach, and offers staff training, ensuring that residents have access to essential health services. The continuous evolution and expansion of these programs demonstrate the department's strong commitment to addressing the changing health needs of the community.

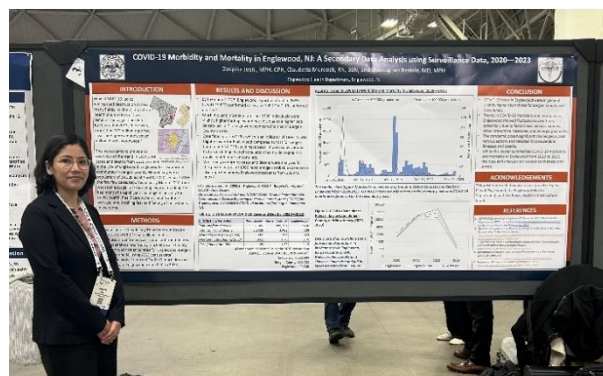
COMMUNICABLE DISEASE SURVEILLANCE IN 2024

The impact of COVID-19 further decreased in 2024. COVID-19 posed a health threat similar to other respiratory viruses like Influenza and Respiratory Syncytial Virus (RSV), especially for those at higher risk. As a result, CDC issued unified Respiratory Virus Guidance in March to provide a practical approach to protect against various respiratory illnesses. Since the end of the federal Public Health Emergency for COVID-19 in 2023, there continued to be a shift away from the emergency response phase to the recovery and maintenance phase in which COVID-19 has been addressed amidst many other public health threats. In Englewood, we continued to see a decrease in COVID-19 cases. Compared to 2023, there was nearly 33% decrease in COVID-19 cases in 2024. Apart from COVID-19, EHD received sporadic reports of waterborne and/or foodborne illnesses including Campylobacteriosis, Cryptosporidiosis, Giardiasis, non-typhoidal Salmonellosis, Shigellosis, Shiga toxin-producing *E. coli*, *Vibrio* infections (excluding *V. cholerae* species), Yersiniosis, and Hepatitis B and C. Other diseases included respiratory and/or vaccine-preventable diseases like influenza, *H. influenzae*, Legionellosis, Pertussis (whooping cough), Varicella (chickenpox), *S. pneumoniae*, *S. pyogenes*, Mpox Clade II, and vector-borne illnesses including Dengue fever and Lyme disease. We received reports of some of these and a few other communicable diseases, which, upon further evaluation or investigation, did not meet the public health surveillance case definition or were found to be false positives. As a result, they may not be noted above. In addition to individual cases of these illnesses, EHD received a few outbreak reports of COVID-19, influenza, and norovirus, particularly in long-term care facility settings, but also a few in community and educational settings in 2024. EHD worked closely with the facilities reporting outbreaks and the Communicable Disease Service branch at the New Jersey Department of Health to manage these outbreaks. Nationally, in 2024, diseases such as Measles, H5N1 bird flu, Mpox Clade I, Pertussis, Dengue, Polio, and a few others made headlines. At local level, we continued our surveillance efforts to prevent and respond to these diseases as we realize that 'A health threat anywhere is a health threat everywhere.

Highlight: COVID-19 Poster Presentation at the American Public Health Association (APHA) 2024 Annual Meeting & Expo

The Infectious Disease Preparedness Generalist had the opportunity to present a poster on COVID-19 Morbidity and Mortality in Englewood at the APHA 2024 Annual Meeting & Expo. The poster analyzed trends in COVID-19 morbidity and mortality among

Englewood residents from 2020 to 2023. It was made possible with the contribution of the PHN Supervisor, former Health Officer, and other Englewood Health Department staff and supported by the Public Health Infrastructure Grant and City of Englewood.



HEALTH EDUCATION

The Health Education Unit consists of the Health Educator and the Local Health Outreach Coordinator. Together, they assess community needs and carry out health education and promotion initiatives aimed at promoting, maintaining, and improving the health of individuals, families, and the community. They organize activities and events for the public or specific groups, such as health fairs, discussion groups, educational presentations, training sessions, seminars, and more. Additionally, they promote healthy lifestyles and support effective behavioral changes by consistently planning, developing, and implementing community-based programs.



Additionally, both the Health Educator and Local Health Outreach Coordinator serve on various committees and coalitions to foster interagency collaboration within the public health sector and

address the needs of our community.

Her hands-on approach and deep commitment to residents have made her a trusted resource and a familiar face in the community. By fostering meaningful relationships, she has helped create a more supportive and healthier Englewood.



Program Highlights

Spring into Wellness! Challenge



Each year, the Health Department hosts a wellness challenge for local residents in collaboration with the Bergen County Community Health Improvement Partnership (CHIP). This year's event, held from May 7th to June 13th, featured twice-weekly meetings with group exercise sessions, free blood pressure screenings, healthy meals, and exciting raffle prizes. Morning and evening sessions were offered to ensure accessibility. The six-week program aimed to reduce isolation and loneliness, while

being specifically designed to meet the needs of Englewood residents. It encouraged daily walks of at least 10,000 steps to boost health and lower cardiovascular risks.



Organizations, such as North Hudson Community Action Corporation, Bergen New Bridge Medical Center and Wellpoint Insurance, provided valuable resources in English and Spanish. The Hope One Bergen County Mobile Recovery Van was on-site for several sessions providing mental health and addiction resources, peer-recovery support services and @Narcans kits. We were even joined by the Director of Bergen County's Mental Health and Addiction Services, Shelby Klein. Englewood Health's Shirvan Family Live Well Center offered nutrition education and healthy meals while the Brain Injury Alliance of New Jersey presented a Pedestrian Safety session. Participants also received free access to the Holy Name Hospital Fitness Center and bottled water from Rica Water.



With registration open throughout, over 80 individuals participated, earning certificates of achievement and the top three winners receiving ShopRite gift cards. Ice Cream on Grand generously donated ice cream for participants on the final day. Participant feedback was overwhelmingly positive.

Summer Steppers PLUS Water Aerobics!



Our Summer Steppers PLUS Water Aerobics program quickly became a city-wide favorite! This six-week program began on July 23rd and encouraged all forty-eight registered participants to continue to stay active after the Spring into Wellness Challenge. This year, we incorporated one evening of stretching and walking Mackay Park's walking path and one morning of water aerobics at Mackay Pool each week. Parks and Recreation provided a lifeguard to ensure safety.



This program also featured summer safety education and community resource tables from many of the same organizations that participated in our spring challenge. Our participants even received special visits and words of encouragement from City Council President Charles Cobb and City Manager Bob Hoffman. Water for participants was generously donated by Rica Water. Evaluations were given in both English and Spanish and were overwhelmingly positive. In fact, this program was so popular, attendees stated they wanted water aerobics twice a week in 2025! Be on the lookout for our Water Wellness: Aqua Aerobics program in July 2025.

Healthy Kids, Happy Families



We had a great deal of fun providing programming specifically for children this year at King's Kid Learning Center, Westside Daycare, Camp Mackay, and Ebenezer Summer Camp. Our programs covered topics such as oral health, nutrition, summer safety, mental/emotional health, germs, and more!



Get Fit in the Fall!



They asked and we listened! When Englewood residents asked us to create a program where they could learn how to safely use the new outdoor fitness equipment at Mackay Park, we knew the Get Fit in the Fall program was the perfect opportunity to pilot an exercise program specifically for this equipment!



Our four-week fall program began on October 29th and featured a morning and evening session each week. We collaborated with Parks and Recreation as well as the Community Chest. Resource tables and free physical therapy consults were provided by Bergen New Bridge Medical Center and Core Care Plus Physical Therapy & Wellness. Water for our thirty-one participants was generously provided by Rica Water. Participants learned techniques to stay safe while using the new outdoor equipment.

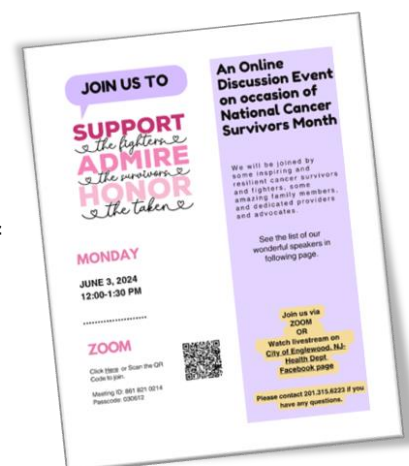
Walk and Talk with the Health Providers!

This summer, the Englewood Health Department organized a 'Walk and Talk with the Health Providers' program at the Flat Rock Brook Nature Center. The six-sessions walking program aimed to promote physical activity, prevent and control chronic diseases, and improve overall health and well-being of community. The program allowed the community to come together, discuss important health topics like hypertension, diabetes, and mental health, while walking through nature. It also strengthened connections between local healthcare providers and the community, fostering social ties that contribute to better health. The sessions provided valuable insights and encouraged relationships between healthcare professionals and participants outside of a work setting.



National Cancer Survivor's Month Online Discussion!

In honor of National Cancer Survivors Month, an online discussion event was held in June. This event aimed to recognize and honor the incredible strength and courage of cancer survivors while raising awareness about the challenges they face beyond diagnosis. A few distinguished cancer survivors shared their experiences with cancer diagnoses, offering words of hope and strength to other individuals and families affected by cancer. During the event, an oncologist, along with a few cancer advocates and community organizations, discussed available cancer support resources. Meanwhile, our Health Education Unit highlighted the Health Department's efforts in raising awareness and collaborations to provide free cancer screening services.

Identifying the Social Determinants of Health

The New Jersey Department of Health (NJDOH) received federal funding which was used towards extending the Strengthening Local Health Capacity Grant for another fiscal year. The goal for the new fiscal year was for Local Health Departments to continue to prevent and address COVID-19 and infectious diseases as well as identifying the Social Determinants of Health within their municipality. Social Support Services

To tackle the major Social Determinants of Health in Englewood, the Englewood Health Department launched a new initiative, *Social Support Services*, under the Health Education Unit on September 1, 2023. Through this program, our Health Educator and Local Health Outreach Coordinator have provided free health counseling, referrals, and direct assistance to the community. Since its launch, the Health Education Unit has provided 91 health counseling sessions and supported 53 families, helping to bridge gaps in care and connect residents to vital resources.

The Office Manager/Sub-Registrar and Health Educator aim to promote the health and wellness of Englewood Residents by increasing their involvement with the Municipal Alliance. The priority for this grant cycle is to reduce alcohol misuse, vaping, and underage drinking and cannabis use.
